CTPD WELCOMES PARLIAMENTARY CONSULTATIONS ON THE DRAFT 8^{TH} NATIONAL DEVELOPMENT PLAN

The Centre for Trade Policy and Development (CTPD) welcomes the parliamentary consultations on the 8th National Development Plan (8NDP) as this is key in terms of making progress towards finalization of the plan, a process which is was way overdue. We do acknowledge the need for the country to have a predictable and detailed development plan in place which can help the General Citizenry understand the aspirations of the Country in the next 5 years. We would like to take advantage of this process and urge Government to ensure that the consultations are done widely, it should be a preserve of only those that live in the line of rail to provide input, added to that is the need to provide alternatives to those constituencies who may be challenged such the deaf.

To provide a background, Development planning in Zambia stems from as far back as 1966, when the country had its first national development plan. This planning was, and still is important in realizing socio-economic priorities for the country especially as it aligns within global and regional frameworks such as the Vision 2030 and the African Union agenda 2023, frameworks to which Zambia is party. Currently in Zambia, the national development plans are in line with the provisions of the National Planning and Budgeting Act No. 1 of 2020 and the National Planning and Budgeting policy of 2014.

A review of the draft 8NDP by the Centre has revealed that Government is proposing to prioritize decentralization, primarily in regards to the strategic objective 4 of the draft policy, on improved policy and governance. CTPD is of the view that this is commendable and is too, something that is long overdue. The Centre remains concerned that the agenda on decentralization has been on paper for many years but less has been done to actualize this. It will be very cardinal that through the 8NDP, this is prioritized even in regards to budgetary

allocations to this agenda. The 8NDP promises to fully implement decentralization by

devolution, which will entail transfer of functions for centralized pattern of decision making

to a local level as well. While this is a good move that should be applauded, CTPD

recommends a rapid implementation of the same to stimulate local development that is locally

driven. CTPD has noted with concern prior the levels of inequality that have continued to

impede on development given the exclusion of a majority vulnerable from key economic

sectors such as Agriculture, Mining and Trade even while the predecessor development plan

promised "leaving no one behind".

The Constituency Development Fund (CDF) is a stepping stone towards decentralization.

CDF has for a long time been a way of bringing development closer to the local people and

has been a vehicle for governments to champion the agenda. CTPD advises that the CDF

provision should be backed by a strong legal framework that can ensure that resources that

are provided are not at the will of an administration but for it to become a legal process where

every Government that comes in place should ensure that more resources are allocated

towards the grassroots.

As the country aims to move towards economic transformation in this sense, there is need for

key legislative provisions that provide for management of public resources such as the Public

Finance Management Act, the National Planning and Budgeting Act and the Public

Procurement Act to be implemented. These were a key part of the predecessor development

plan, but there enforcement remained weak. There is therefore still need to further strengthen

these pieces of legislation to ensure that they are implemented and enforced accordingly.
